RULES AND REGULATIONS

1. All cart operators **MUST** have a valid driver's license and proof of insurance. This is a Fripp/Harbor Island policy.
2. Familiarize yourself with and observe all traffic rules:
 - use hand signals when turning or stopping
 - rental golf carts are not allowed on the golf course, beach or bike paths
 - rental carts cannot be parked in fire lane
3. Maximum of five (5) persons, regardless of age, on golf cart at any one time.
4. **PLEASE** park the golf cart in a safe place at night do not leave out uncovered.
5. This is an electric golf cart, which requires periodic charging. The charger is either in the garage or on the golf cart—do not remove from the premises. Be sure the cart has a good charge before leaving for an extended ride. **ALWAYS** unplug the charger before moving the golf cart. **ALWAYS** recharge when not in use, you cannot overcharge the golf cart batteries. When you sense that the cart is losing power (i.e. sluggish, slowing down), it needs charging. An overnight charge should last a couple of days of normal use.
6. Please rinse the cart when needed.
7. Be **SURE** to turn the headlight(s) **OFF** when not in use.
8. Note that the cart has forward, reverse and neutral gears. When in reverse, you should hear a backing horn (buzzing sound).
9. If you are familiar with golf carts and **ONLY IF** you know how, please check the water level in the battery. Add water only after charging.
10. Please take the key out of the cart when not in use.

12. There will be a \$10.00 charge for each sticker that is left on the golf car.
13. There will be a \$10.00 charge for missing key that is not returned to Owner.

GENERAL TERMS OF RENTAL

4. defend, indemnify and hold the owner & his/her agent(s) harmless from and against all claims, suits and liabilities, without limiting the generality of the foregoing, for any and all damages to property or person, including, but not limited to injury, death, or damage to any property whatsoever, caused by, arising from, incident to, connected with, growing out of, or related to the use and/or operation of this golf cart during this rental period.

FURTHERMORE, I REPRESENT THAT I AM FAMILIAR WITH THE OPERATION AND USE OF SUCH GOLF CART, THAT I HAVE READ THE RULES AND INSTRUCTIONS CONTAINED HEREIN, AND THAT I AM CAPABLE OF OPERATING THE GOLF CART SAFELY AND IN ACCORDANCE WITH SAID RULES AND INSTRUCTIONS.
